How the NexusACO plan works.

Employees and their families in the NexusACO plan are required to select a primary care physician (PCP) who will oversee their care and provide referrals to specialists. By choosing either an Advocate Health Care or a Tier 1 PCP, employees receive the greatest value for their health care benefits.

In the 7-county NexusACO service area, employees need to select an Advocate Health Care PCP to get Tier 1 benefits. In the 7 counties outside the NexusACO service area, employees need to select a UnitedHealth Premium® program PCP to receive Tier 1 benefits. Employees may also select a Tier 2 PCP in these counties but they could receive lesser value for their benefits.

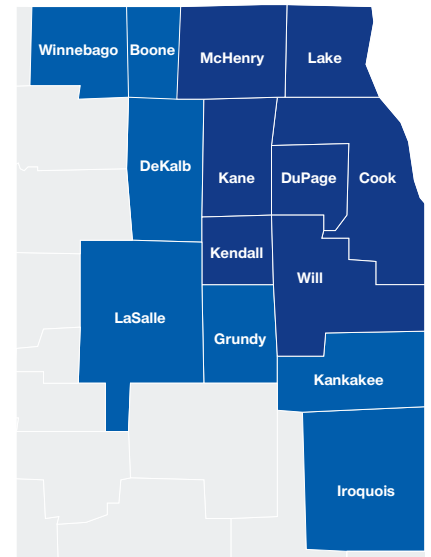
Employer groups must be situated in one of the following 14 Chicagoland counties: Boone, Cook, DeKalb, DuPage, Grundy, Iroquois, Kane, Kankakee, Kendall, Lake, LaSalle, McHenry, Winnebago, or Will.

Enrolled NexusACO employees must either live in one of the 14 Chicagoland employer-situated counties or in one of the following Northwest Indiana counties: Lake, LaPorte or Porter.

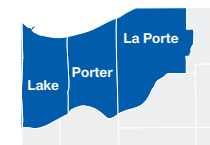

The 7 counties in dark blue represent the NexusACO service area, where Advocate Health Care providers are located.

The medium blue counties also represent NexusACO's service area where Tier 1 PCPs exist; however, Advocate Health Care providers are not found in these counties.
